**Prerequisites:** Six credits in political science.

## **Course Objectives:**

- 1. To understand human / environmental interactions as governance issues.
- 2. To identify how the distribution of effects and responsibilities for environmental degradation shifts over time.
- 3. To explore the lenses used to create and evaluate environmental policy.
- 4. To conduct multi-level policy analysis of global environmental problems from development to remediation.
- 5. To communicate scientific and technological concepts to policymakers.

#### **Evaluation:**

Exams – 30% (combined total course grade)

Exams will each be available in Blackboard for one week. They are not proctored. You may download the exam and take as much time as needed during the week to complete it. The exam must be turned in to the appropriate assignment folder in blackboard. Exams are essay based. You will select one of three possible topics and address the required components in paragraph form. Usually between 2 and 5 double spaced pages is sufficient, but no specific length is required as long as you thoroughly respond to the prompt with relevant examples from the exam and additional research (sources other than the course material must be cited using a recognized format MLA/APA/Chicago). Exam are graded out of 50 points each.

**Mid-term Exam** – 15% of total course grade (*Course Objective 2*)

# Policy Brief Project – 20% combined total course grade (Course Objective 5)

All project components are graded out of 50 points each and follow this format:

Environmental Issue Identification including supporting graphic—10 points

Audience – 10 points

Target Population – 10 points

Policy Proposed – 10 points

Mechanics (Length and Citations) – 10 points

Paper headers should include a title and your name not any additional information about the instructor or course. Sources other than the course material must be cited using a recognized format MLA/APA/Chicago. Citations do not count toward page length.

### **Policy Proposal** – 5% of total course grade

Select an environmental issue that concerns you and propose a policy solution. Explain why you selected that issue and policy approach. Include a graphic (picture / table / chart / model / map related to the issue – counts towards page length) in a 1-2 pages single spaced document. This should be completely your idea based on your existing understanding of the issue and policy options. The realities of the environmental and political processes will be discussed later in the course. Your grade will not be reduced if your current understanding is limited.

## **Policy Pitch** – 5% of total course grade

Revise your original policy proposal with your new understanding of pollution and conservation problems and environmental policy development. Record a 3-5 minute audio or video clip (via zoom, your cellphone, or another software program / device) in which you present the scientific and political reasoning for the policy you propose including the description or image of a supporting graphic you are developing to support the proposal.

## **Policy Brief** – 10% of total course grade

Expand upon your policy pitch and write a 1 - 2 page single spaced policy brief with the compelling original graphic you developed for the political actor that might support your proposal. Examples will be provided.

## **Discussion Board Activities** – 50% combined total course grade (*Course Objectives 1 and 3*)

These activities will be completed in groups of 6-9 students. You will read one of the three topics available and post a 2-4 paragraph summary the first week of the module. The second week of the module you will make a 1-2 paragraph comment on two of your peer's posts, one for each of the topics you did not summarize. Five modules feature these activities. The summary and comment posts for every activity are graded out of 50 points each.

Summary – 25% of total course grade (5 @ 5% each)

Explain applications to the module topics - 25 points

Explain disconnect with any module topics that are not applicable - 25 points

**Comments** – 25% of total course grade (10 @ 2.5% each)

How does your peer's topic differ from yours? - 25 points

How is your topic applicable to your peer's? - 25 points

### **Course Policies:**

**Regular Course Withdrawal** -- Withdrawal from classes occurs after the deadline to drop classes has passed.
